Targeted towards construction/maintenance contractors doing work on Navy installations and facilities, this training covers management practices to help maintain air quality compliance and control air emissions on the job site. Topics include installation restoration, protection of cultural and natural resources, air emissions, ozone depleting substances, hazardous materials and the community right-to-know act (EPCRA), control and disposal of hazardous waste, asbestos, polychlorinated biphenyls (PCBs), solid waste and recycling, pesticide application and use, spill prevention control and countermeasures (SPCC), storage tanks, storm water, environmental management systems (EMS), and ECATTS certificates.

ENVIRONMENTAL REQUIREMENTS FOR CONTRACTORS AND VENDORS

This training targets contractors and vendors working on DoD/Navy installations and facilities. Training covers the responsibilities to comply with federal, state and local environmental regulations, as well as military environmental plans, instructions and requirements. It provides basic information on the following areas of responsibility: Environmental Management System (EMS), environmental policy, general environmental awareness, water quality, used oil, air quality, hazardous waste management, hazardous materials, polychlorinated biphenyls (PCBs), asbestos, solid waste management, good housekeeping, natural resources, and spill response.

HAZWOPER: FIRST RESPONDER AWARENESS VIDEO TRAINING

Targeting personnel who work in areas where hazardous materials are used and stored, this course provides an overview of duties of the first responder in a hazardous materials accident. HAZARDOUS WASTE

It offers a familiarization with the types of POL that are typically found at installations, facilities where it is stored, POL storage containers, tanks and secondary containment, and management guidelines for used oil and POL.

It contains DoD/Navy information and will help construction/maintenance contractors maintain compliance with environmental rules and regulations by knowing how to properly manage special wastes such as aerosol cans, antifreeze, batteries, compressed gas cylinders, empty drums and containers, fluorescent lamps, mercury–containing materials, paint waste and solvents, contaminated rags and absorbent material, used oil and oil filters.

WASTEWATER
